This signed document is an agreement between **The Reliable Horse & Pet Sitter** and _____ (Client) for pet care services. **The Reliable Horse & Pet Sitter** agrees to provide pet sitting services in a reliable, trustworthy, and caring manner.

PET CARE

1. I authorize **The Reliable Horse & Pet Sitter** to perform pet sitting services as outlined in the Pet Information & Veterinary Release Form, which shall become part of this contract.
2. I authorize **The Reliable Horse & Pet Sitter** to obtain any emergency veterinary care that may be necessary during the time spent with my pet. I accept responsibility for any charges related to this emergency care. I also authorize **The Reliable Horse and Pet Sitter** to utilize an alternative veterinarian in the event my primary veterinarian is unavailable. **The Reliable Horse & Pet Sitter** will make every effort to contact the owner/ client prior to obtaining any emergency care for pet(s).
3. Client/ Owner must disclose to **The Reliable Horse & Pet Sitter** any and all other persons having access to the home and property during the duration of the contract. **The Reliable Horse & Pet Sitter** accepts no responsibility for security of the premises, other than to shut gates, pens, and cages as instructed by the client/ owner. **The Reliable Horse & Pet Sitter** neither accepts responsibility for loss or stolen property, or animals. Pet and livestock care will be performed only by **The Reliable Horse & Pet Sitter** during the duration of the contract unless prearranged with the client/ owner.
4. I agree to reimburse **The Reliable Horse & Pet Sitter** for any additional fees for providing emergency care, as well as any expense incurred for unexpected visits, transportation, housing, food, or supplies.

5. **The Reliable Horse & Pet Sitter** agrees to provide the services stated in this agreement in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes any and all claims against **The Reliable Horse & Pet Sitter**, spouse or assigns, except those arising from a proven negligence of the pet sitter.
6. **The Reliable Horse & Pet Sitter** will not be liable for the injury, disappearance, death, or fines of any pet with unsupervised access to the outdoors. This includes injury to or from livestock due to damaged fences, barns, sheds, or other faulty livestock enclosures.
7. **The Reliable Horse & Pet Sitter** reserves the right to terminate this contract at its sole discretion; likewise, client/ owner may terminate this contract. Clients must give a minimum of 24 hours notice to receive a refund for canceled visits. Currently **The Reliable Horse & Pet Sitter** will take the following forms of payment: Cash, Check, or Cashier's check. A fee of \$50.00 will apply to all returned checks. The owner/ client is responsible for all costs of collection on returned checks or unpaid balances.
8. It is expressly understood that **The Reliable Horse & Pet Sitter** shall not be held responsible for any damage to client's property, or that of others, caused by client's pets during the period in which they are in its care.
9. I attest to the fact that all license and vaccinations required by the State of OK, the city in which I reside and/or the County are current according to the law. _____ (initial here).

I authorize this contract to be valid approval so as to permit **The Reliable Horse & Pet Sitter** to enter my premises during specified contract dates without additional signed contracts or written authorization in order to perform pet sitting services discussed in consultation meeting and in this contract.
